- 3. Sasco Screens & Blinds Pty Ltd shall only be responsible for supplying the product/s, and accepts no responsibility for any advice given regarding any matter concerning the product/s.
- 4. The full purchase price balances shall be payable on the day of product installation. Failure to pay full purchase price on demand will entitle Sasco Screens & Blinds Pty Ltd to retake possession of the product/s without being liable in trespass or otherwise to the customer, and to retain any deposit or any other moneys paid by the customer pending full settlement or guarantee to pay the full purchase price balance, and to claim any other costs incurred by Sasco Screens & Blinds Pty Ltd as a result of retaking possession of the product/s should the customer fail to pay the full purchase price balance on installation of the product/s.
